THE BRAZILIAN DEVELOPMENT BANK (BNDES) is a federal public company and the main instrument of the Federal Government for long-term financing and investment in the various segments of the Brazilian economy. As a bank serving the State, we also structure denationalization projects (public-private partnerships, concessions and privatizations) with the aim of attracting investors for the country's infrastructure. We have operated since 1952 and are one of the largest development banks in the world.

BNDES is rendering services that aim to assist the public sector in attracting private capital to environmentally sustainable projects and social investments in sanitation, health, education, street lighting, forests and parks management, among others. The solution is focused on bringing more quality to public services with transparency, independency and efficiency.

The Project Factory allows BNDES to act as one-stop shop: seeking opportunities within the public sector, providing privatization structuring services, for both a concession-based approach for infrastructure projects and the divestitures of several public enterprises/state-owned assets, and promoting these projects to investors, besides providing financing instruments.

BNDES as a one-stop shop

The Project Factory allows BNDES to act as a Bank serving not only the State, but the Brazilian people, acting to improve the quality of their lives while promoting sustainable development. In September 2020, the Project Factory was engaged with a total of 78 projects: 30 federal, 34 state and 14 municipal with expected investments totaling up to USD 30 billion, many in social infrastructure, including sanitation and water, street lighting and public parks.



For the sanitation and water sector alone, there are nine supported projects that will benefit 36 million people with sewage and treated water. Among many environmental and health benefits, these water/sewage projects are expected to inject up to USD 10 billion in new investments in the economy. A new legal framework bill for sanitation and water was approved this year, a measure that will help to foster this sector. In September, two of these supported projects were successfully auctioned: Alagoas, in the form of concessions, and Cariacica, in the form of a PPP program.
